RedRover Grants Give Safe Haven to Defenseless Pets Lifesaving Grants Help People and Animals Escape Abuse

Sacramento, CA (September 29, 2020) – RedRover has awarded more than \$250,000 in Safe Housing grant funds during the first grant cycle of 2020. RedRover's <u>Safe Housing</u> grants not only enable domestic violence shelters to create on- and off-site space to house pets, they also allow animal shelters to build dedicated housing for animal victims of abuse. Of the 15 grants awarded, six are RedRover + Purina <u>Purple Leash Project</u> grants, an extension of RedRover's Safe Housing program. And in the first grant cycle of its kind, five <u>Safe Housing Animal Shelter grants</u> were awarded for a total of \$100,000 in four states.

Since the program's inception in 2012, RedRover has given 125 grants totaling more than \$1.2 million.

RedRover President & CEO Nicole Forsyth states, "These grants can give so many domestic violence survivors and their pets a chance for a fresh start in life, free from manipulation and abuse. We are committed to bringing more pet-friendly spaces to as many shelters as we can to ensure no one has to choose between their safety and their pet."

According to research conducted by Dr. Frank Ascione, <u>as many as 71 percent of pet-owning women</u> entering domestic violence shelters report their abuser injured, killed or threatened family pets for

revenge or psychological control. Additionally, up to 48 percent of domestic violence victims reported delaying leaving their abusers because they feared what would happen to their pets.

RedRover and Purina are working towards the goal of having at least one pet-friendly domestic violence shelter in each state. Currently, Hawaii, Mississippi, New Hampshire, and Rhode Island have NO pet-friendly domestic violence shelters.
