**REDROVER RELIEF - IN 2024, REDROVER RELIEF PROVIDED GUIDANCE, REFERRALS, CASE MANAGEMENT, AND FINANCIAL ASSISTANCE TO 5,810 GOOD SAMARITANS, ANIMAL RESCUERS AND PET OWNERS, HELPING THEM OBTAIN EMERGENCY VETERINARY CARE FOR ANIMALS IN LIFE-THREATENING SITUATIONS. REDROVER RELIEF CASE MANAGERS AWARDED 553 REDROVER RELIEF GRANTS, TOTALING \$157,472 FOR THESE ANIMALS IN CRISIS. **REDROVER RESPONDERS - IN 2024, REDROVER RESPONDERS DEPLOYED 13 TIMES. WE HAD 2,959 VOLUNTEER HOURS AND HELPED A TOTAL OF 2,541 ANIMALS. AT THE END OF JANUARY, WE SENT A TEAM OF VOLUNTEERS TO TULSA, OKLAHOMA, TO ASSIST THE HUMANE SOCIETY OF THE UNITED STATES WITH THE SHELTERING AND CARE OF 76 ANIMALS RESCUED FROM AN ALLEGED CRUELTY SITUATION. IN SEPTEMBER, THE REDROVER RESPONDERS TEAM WAS ON THE GROUND IN NORTH CAROLINA HELPING TO SHELTER ANIMALS DISPLACED BY HURRICANE HELENE. SHELTERS AND ANIMAL ADVOCACY. VOLUNTEERS AND REDROVER STAFF HELPED SPREAD THE WORD ABOUT OUR WORK AT 57 EVENTS AND CONFERENCES. IN JANUARY 2024, REDROVER ENDORSED THE ANIMAL VIOLENCE EXPOSES REAL THREAT OF FUTURE VIOLENCE (AVERT) ACT AT THE REQUEST OF CONGRESSWOMAN DINA TITUS. THE AVERT ACT AIMS TO UNDERSTAND AND RESPOND TO THE LINK BETWEEN ANIMAL CRUELTY AND FUTURE ACTS OF INTERPERSONAL VIOLENCE. SPECIFICALLY, THE BILL COMMISSIONS A DEPARTMENT OF JUSTICE STUDY TO ASSESS THE LINK BETWEEN THESE CRIMES AND AUTHORIZES A \$2 MILLION ANNUAL GRANT PROGRAM TO SUPPORT MENTAL HEALTH EXPERTS, LAW ENFORCEMENT, AND ANIMAL WELFARE ORGANIZATIONS IN THEIR EFFORTS TO STOP ANIMAL CRUELTY AND REHABILITATE OFFENDERS.

IN ADDITION, ANY AMENDMENT OR REPEAL OF THE BYLAWS THAT WOULD MATERIALLY AND ADVERSELY AFFECT THE RIGHTS OF THE MEMBERS AS TO VOTING OR TRANSFER MUST BE APPROVED BY THE MEMBERS (INCLUDING A REQUIREMENT OF UNANIMOUS APPROVAL BY THE MEMBERS AS TO CERTAIN PROVISIONS OF THE BYLAWS).

THE BOARD OF DIRECTORS HAS WORKING COMMITTEES, BUT NONE OF THEM HAVE THE AUTONOMY TO ACT ON BEHALF OF THE GOVERNING BODY. THE FINANCE COMMITTEE MANAGES THE ORGANIZATION'S INVESTMENTS AND REPORTS TO THE BOARD QUARTERLY THROUGH MEETING MINUTES AND APPROVAL REQUESTS FOR NON-ROUTINE INVESTMENT TRANSACTIONS. INVESTMENT STRATEGIES MUST CONFORM TO THE BOARD OF DIRECTORS' INVESTMENT POLICY, WHICH IS ANNUALLY REVIEWED AND REVISED AS NECESSARY.
